License agreement for the publication in the repository of TU Dortmund University

For primary publications:

Non-exclusive right of publication

By accepting this provision, TU Dortmund University, hereinafter referred to as the operator, is granted the nonexclusive right to store the resource and its metadata, to reproduce it, to make it accessible worldwide, and to make printed and electronic copies as required.

Transformation into other formats

Acceptance of this provision grants the operator the right to transform the resource into other electronic and physical formats as required (e.g., migration, accessibility, improved availability, indexing) and to exploit them in accordance with Section 1.

Indemnity against third-party claims

The publishing author assures that the work to be published or parts thereof do not violate any rights of third parties. If alleged or actual infringements of the rights of third parties are asserted after publication, the publisher assures that he/she will inform the operator immediately. The publisher shall indemnify the operator upon first request against all claims of third parties, in particular claims for infringement of copyright and personal rights, which may be asserted against the operator in connection with the exercise of the rights which are the subject matter of this provision. The publisher must inform the operator immediately of any infringements of the contractual rights of

which he/she becomes aware.
